

Notes from the Seed Counter

The 1990 Seed Counter raised over \$2400 for the Society. Over 2000 packs were sent to 97 U.S. and 44 foreign members and friends. A bulk order of four pounds was also filled. If bulk orders are needed for understock, etc., please contact the seed chairman in order to arrange necessary donations. Contributors of seed who were not included on the seed list include C. E. Tubesing (OH), W. K. Robinson (PA), and P. Noel (France). The contributors totaled 26. Seed not listed was distributed among many orders as extra packs.

Contributions for next year's Seed Counter must be received by January, 1991. This will permit earlier distribution of seed. Because of the large increase in seed contributions and orders, non-magnolia seed will be distributed separately from magnolia seed. This means that you will have to send in two orders instead of one if both seed types are desired. However, this will result in better and faster service to you from the volunteers on the Seed Committee. Also, remember that all Canadian orders require that a Canadian Import Permit accompany the order.

Domestic contributors this Fall should send non-magnolia seed to Bob Barnard, Maple Leaf Nursery, 4236 Greenstone Road, Placerville, CA 95667 (916-626-8371). Domestic contributors of magnolia should continue to send it to Ray Tessmer, 4432 James Lane, Chattanooga, TN 37416 (615-698-6879). All foreign contributions should continue to be sent to Ray Tessmer. Please write to him for an import permit and mailing instructions. Seed from "down under" will be stored for distribution the following Spring.

To assist contributors in estimating the demand for each seed variety, the following tabulation shows the number of packs ordered for each seed type this year. Remember that magnolia seed orders were limited to a certain number of packs, depending on supply.
